Workplace Safety

We have all seen the stories of the increase in workplace violence directed at healthcare workers. Most recently there have been attacks on hospital staff in Florida and Pennsylvania. We must work as a team to keep ourselves safe. One way that we can work towards a safer workplace is for EMS to do a verbal screening for weapons prior to transporting a patient. Make it a daily part of your practice to screen your patients. Ask them, "Do you have any type of weapons on you such as guns, or knives?" If they respond in the affirmative, politely ask them to leave these items at home, and reinforce to them that they will not be allowed to keep possession of any type of weapon once they arrive at the ED. Taking this simple step will help to keep your crews safer in the back of the squad, as well as our ED team.

Strangulation Cases

Strangulation is a serious crime that has historically been minimized, but recent legislative changes highlight its significance, especially in cases of domestic violence, elder abuse, and child abuse. In July 2019, Kentucky became the 48th state to recognize strangulation as a felony. Prior to this, it could only be charged as a misdemeanor assault, often only with visible injuries.

For Emergency Medical Services EMS, it's crucial to approach cases of strangulation with awareness and caution. Remember these key principles when responding to these calls:

- 1. **Be trauma-informed and empathetic:** Strangulation is a terrifying and traumatic experience for victims, and they may be in shock or hesitant to speak about it.
- 2. **Document everything:** Injuries from strangulation can be internal, and it's essential to document both visible and potential internal injuries, even if there are no external signs. This can include hoarseness, difficulty breathing, or red spots on the skin.
- 3. **Encourage medical evaluation:** Even if there are no obvious injuries, internal trauma such as vascular dissections may occur, and only advanced imaging like CTA can detect them.
- 4. **Forensic exams:** If the victim is brought to the St. Elizabeth ED, a forensic exam may be performed, potentially including touch DNA collection from the neck.

Your attention to detail and understanding of these principles can make a significant difference to the outcome of these cases.

CARES Registry/Database

St Elizabeth Healthcare is now participating in the CARES Registry. CARES is used in state and national databases and helps to "Measure outcomes, improve care, and saves lives". This can be accomplished through a simple add on to your reporting software.
